Goureh –Jask Crude Oil Pipeline Project

Construction of a crude oil pipeline from Goureh oil terminal to the east of Jask with the capacity of 1,000,000 bpd to attain the following objectives:

- Reducing reliance on one water way channels and increasing the reliability of crude oil exports
- Reducing the distance of export markets and in a nut shell increasing the competition in export markets

Jask Oil Storage Terminal Project

Oil storage terminal with the capacity of 20,000,000 bpd of crude oil in Jask port, planned to be constructed to attain the following objectives:

- Increasing the storage capacity of crude oil
- Use the appropriate sales opportunities and the current price
- Reducing the maintenance costs at special conditions
- providing more reliable attraction for customers
- The terminal will be built by the private sector and its costs secured by the income from leasing the storage tanks

Shiraz Pars Farayand Refinery project

Today, the "strategic situation" and "abundant hydrocarbon resources" are the two important factors in attempts to revive the Silk Road. Therefore, studying the role and situation of Iran is considered to be very remarkable, not only by policy-makers and macro-planners of the country, but by regional and international statesmen and economists as well. Iran possesses abundant natural resources, including iron, aluminum, oil, gas and many others which offer ample investment opportunities in different industries. These huge oil and gas resources, which are readily available and cost-effective, have paved the grounds for the expansion of petrochemical industry in Iran.

National Petrochemical Company

National Petrochemical Company of Iran, as one of the four main deputies in the Oil Ministry, is responsible for strategic management and macro planning, policy making, coordinating and supporting sustainable development of the country's petrochemical industry.
